## Happy February, Agents!

Here are a few tidbits we wanted to share with you:

**Dexcom G6 CGM System:** This device does require a Pre Determination, and once approved, it will be covered under Part B at the pharmacy at a 20% coinsurance.

**Freestyle Libre CGM:** The Freestyle Libre is a \$0 coinsurance for preferred and 20% cost share for non-preferred. This brand is one of the preferred brands (OneTouch, Precision, and Freestyle) that HealthTeam Advantage covers at 100%.

**Relion Novolog:** This insulin is Non-Formulary. This is Walmart's brand of insulin; we do not cover this as part of the Senior Savers Model. If your client is at the pharmacy and runs into this issue, please have them ask the pharmacy to run the name brand Novolog. If your client wishes to continue to have the Relion Novolog filled, they will have to make a Non-Formulary request with HealthTeam Advantage. The client can call member services to initiate.

\*\*\* Please be advised there is no \$0 Insulin for PPO members. NF insulins will be \$35 per month as dictated by the Inflation Reduction Act (IRA).

### **Member ID Numbers**

Starting this year, members who are new to HTA PPO or CSNP plans will be assigned a T98080 ID number. Previously, CSNP members were assigned ID numbers that started C98080. Also, if a client moves from the PPO to the CSNP, their ID number will not change. They will keep their T98080 ID number on the CSNP.
