## **New Plans, New Benefits in 2024!**

It's almost that time again — the Medicare Annual Enrollment Period, or AEP, runs from **October 15 through December 7,** 2023. We're excited to introduce two new plans and some exciting new benefits for our members!

## **Introducing Eagle PPO and Cardinal HMO**

In addition to our PPO I, PPO II, and HMO-CSNP plans, we will offer two new plans for 2024, the Eagle and the Cardinal:

- The Eagle is a PPO plan with a \$0 premium, \$0 medical deductible, and \$0 copay for in-network primary care providers. Please note that there is no Medicare Part D prescription drug coverage with this plan.
- The <u>Cardinal is an HMO plan</u> with \$0 premium, \$0 deductible for medical and prescriptions, and \$0 copay for in-network primary care providers and specialists. Since this is an HMO plan, you must use providers in our network.

#### **New Benefits for PPO and CSNP Plans**

We are excited to announce some updates coming to our current plans in 2024:

- Quarterly OTC allowance (added to all plans)
- Meal delivery after a qualifying procedure
- Companionship services benefit
- Memory fitness benefit
- Transportation benefit (for CSNP and Eagle plans)
- Reduced premium for PPO II plan to \$50



#### **Expanding Our Coverage Area**

We're making our plans available to more North Carolinians in 2024! Our coverage area for the PPO I, PPO II, and **Eagle plans** will include Orange County next year, in addition to the 11 counties we currently serve.

For our Diabetes and Heart Care (HMO-CSNP) and Cardinal plans, we're expanding our coverage area into Davidson, Davie, and Forsyth counties. This means these plans will be available in 7 North Carolina counties next year.
